What is the overall <u>deductible</u> ?	\$0 at IHCP or with IHCP referral at non-IHCP; \$5,500/individual or \$11,000/family. Doesn't apply to <u>Preventive care</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible?</u>	Yes. Preventative care services, primary care provider and specialist visits, and generic drugs are covered before you meet your <u>deductible</u> .
